We are pleased to present the 16th Annual Report for the City/ County Association of Governments (C/CAG) of San Mateo County, covering the fiscal year from July 1, 2009 to June 30, 2010. The C/CAG Board is made up of representatives from every city, the County, and County transportation agencies in San Mateo County. C/CAG serves San Mateo County as the official:

- Congestion Management Agency (CMA)
- Airport Land Use Commission

- Solid Waste Local Task Force
- Countywide forum for common issues

Despite the challenging economic times, C/CAG was able to work successfully through critical local and regional issues that significantly affect the quality of life of every person who lives, works or travels through our beautiful County. By working together, we can address regional topics and challenges with synergy and efficiency. Our main focus is on the following six programs:

- > Traffic Congestion Management
- Storm Water Pollution Management
- > Transportation for Clean Air

- > Abandon Vehicle Abatement
- ➤ Airport/Land Use
- Climate Protection

C/CAG also participates in solutions for San Mateo County housing. C/CAG coordinates countywide expertise to create solutions in compliance with State mandates for storm-water run-off which no individual city could effectively afford to do on its own. The cornerstone projects and programs for this year included:

- 1. The San Mateo County Smart Corridors project Phase One currently under construction. It will provide real-time traffic management tools and enable cross-jurisdictional communication.
- 2. Updating of the Countywide Transportation Plan. It is a long-range planning document that sets out the county's vision on transportation for the next 25 years.
- 3. The initiation of a San Mateo Countywide Safe Routes to School program.
- 4. Implementation of San Mateo County Energy Watch.
- 5. Initiation of the development of Measure M \$10 Motor Vehicle Fee dedicated to Transportation Improvements to our local streets and roads in San Mateo County.


Green Streets and Parking Lots

- Received the 2009 Award for Innovation in Green Community Planning from the California Chapter of the American Planning Association for the "San Mateo County Sustainable Green Streets and Parking Lots Design Guidebook."
- Four stormwater demonstration projects were constructed at Brisbane's City Hall, Burlingame's Donnelly Avenue parking lot, Daly City's Serramonte Library, and on 3rd Avenue in San Bruno.
- Partnered with San Francisco Estuary Institute to perform water quality monitoring at Daly City project to demonstrate benefits of green streets and parking lots.
- Presented Green Streets and Parking Lots Program at International Low Impact Development Conference and American Society of Landscape Architects' Annual Conference.

San Mateo County Energy Watch 2010 kWh Savings Achieved vs. kWh Savings Goals



San Mateo County Energy Watch

- Local Government Partnership with PG&E.
- Provide \$2.5M in incentives over 3 years for San Mateo County Energy savings projects.
- Municipal, commercial, and residential programs.
- Three-year goal to save 9,942,000 kWh and 125,000 therms.

Climate Action

- Established Resource Management and Climate Protection Committee.
- Completed cities' communitywide greenhouse gas emission inventories.
- Since 2009 reached energy reduction goal of 4.6 million kWh under the San Mateo County Energy Watch.
- Began development of, and gained funding for, climate action plan template for cities and County.

Program Performance

Congestion Management Program

Programmed \$12.8M in Federal funds for projects for local street, regional bicycle, pedestrian streetscape, and "safe routes to school."

Awarded \$1.5M for the 2nd Cycle Lifeline Transportation Program. Allocated \$564,000 to 2 municipalities for streetscape projects.

Allocated \$1,574,000 to 5 municipalities for bicycle and pedestrian projects.

Allocated \$1,632,000 to 4 municipalities for transportation projects for the 4th cycle Transit Oriented Development program commitments.

Environmental/Transportation Program

\$1,147,113 Programmed for Local Projects - Results:

- Streets/roads resurfaced
- Signal upgrades
- Streets/roads sweeping
- Storm drain inlets and catch basins inspected/cleaned

Allocated \$1,019,000 in State Clean Air Funds to two agencies for clean air projects to improve air quality.

Cost effectiveness of \$22,026 per ton of pollutants with 39.12 tons eliminated from the air.

San Mateo Congestion Relief Plan

Funded \$786,398 for seven city shuttle programs and one employer shuttle to serve over 330,000 passengers per year.

Prepared Environmental Study for Smart Corridor.

Peninsula Traffic Congestion Alliance funding of \$509,000 for Countywide Travel Demand Management (TDM) services.

Continued partnership with SamTrans and Valley Transportation Authority (VTA) on Grand Boulevard Multi-modal Transportation Corridor Plan.

Turned on metering lights along northbound I-280 between San Bruno and Daly City.

Airport Land Use Commission/Plan

Three airport/land use plan consistency reviews of proposed local agency land use policy actions within an airport environs.

Reviewed a major environmental document for the expansion of a waste disposal and recycling facility near San Carlos Airport.

Continued work on the Comprehensive Airport Land Use Compatibility Plan (CLUP) update for the environs of San Francisco International Airport (SFO).

Meetings with SFO, C/CAG, and city staff to discuss key airport/land use compatibility issues and facilitate criteria to be addressed in the SFO CLUP update.

Stormwater Management Plan

Assisted municipalities in meeting new regional stormwater permitting requirements.

Continued providing stormwater education and outreach through www.flowstobay.org, with a 46% increase in visitors.

Coordinated California Coastal Cleanup Day in San Mateo County, at which over 4,000 volunteers removed over 44,000 pounds of litter from local waterways.

Awarded \$15,000 to six organizations through Community Action Grant Program to improve water quality.


Provided 22 assemblies at elementary schools, educating over 4,000 students about stormwater pollution issues.






